

## MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This agreement entered into by and between:

The DEPARTMENT OF AGRICULTURE-REGIONAL FIELD UNIT, CORDILLERA ADMINISTRATIVE REGION, with office address at Guisad Road, Baguio City, represented by its Regional Executive Director, **CESAR D. RODRIGUEZ**, herein referred to as the "DA-RFU, CAR";

and

The **BUREAU OF AGRICULTURAL STATISTICS**, an attached government agency, with office address at Ben-Lor Bldg., 1184 Quezon Avenue, Quezon City, represented by its Director, **ROMEO S. RECIDE**, referred to as "BAS".

### WITNESSETH

**WHEREAS**, the DA-RFU is implementing major agricultural programs to alleviate poverty and attain food security;

**WHEREAS**, there is a need to segregate the agricultural lands especially for major crops like rice and corn and their potentials in relation to productivity;

**WHEREAS**, the DA-RFU-CAR aims to update the physical area and productivity benchmarking profile of these crops to come-up with relevant data for development planning, policy formulation and program interventions;

**WHEREAS**, other government agencies with concerns in agriculture are also generating agricultural data for their own use;

**WHEREAS**, different data gathered by other agencies are accounted by difference in methodology including the scope and coverage;



**WHEREAS**, there is a need that a unified agriculture and fishery data validated by all concerned agencies be made available for official reference and could be shared by all agencies concerned;

**WHEREAS**, DA-RFU CAR through GMA programs is among those in need of the validated official database by municipality, land types, and irrigation systems in terms of physical area and productivity;

**WHEREAS**, the Bureau of Agricultural Statistics (BAS) is the official source agency of agriculture and fishery data;

**WHEREAS**, BAS has limited financial and manpower resources to undertake the validation of data up to barangay/municipal level that are urgently needed by DA-RFU, CAR and attached agencies;

**NOW THEREFORE**, for and in consideration of the above-mentioned premises, the parties have agreed on the following:








**A. DA-RFU CAR shall:**

1. Provide financial assistance through fund transfer in the amount of **Two Million Five Hundred Thousand Pesos (Ph 2,500,000.00)** for the conduct of agriculture and fishery data generation enhancement and updating as per approved work and financial plan;
2. Coordinate and provide BAS ROC CAR the basic information that needs to be generated as basis in preparing the questionnaires and reporting formats including appropriate softwares to be used; and
3. Validate and conduct further analysis of the data submitted prior to finalization of output.

**B. THE BAS SHALL:**

1. Submit work and financial plan of the project for approval by DA-RFU, CAR;
2. Designate field staff involved in the project;
3. Formulate sampling frames, prepare survey instruments and develop processing systems for the project;
4. Conduct briefings for personnel involved in the execution of the project;
5. Conduct/supervise data gathering activities relative to the project;
6. Process survey returns;
7. Conduct data analysis/review/validation before finalization of reports;
8. Assist the DA-RFU, CAR team who shall validate the information submitted;
9. Present to DA-RFU CAR, other attached agencies, and local government units the results of the data gathered;
10. Provide hard and electronic copies of the results to DA-RFU CAR. The attached agencies and provincial LGU's shall also be given electronic copies;
11. Maintain hard and electronic copies of the results in all BAS provincial offices as back up file in case other agencies might need it in the future;
12. Prepare and submit progress report to DA-RFU, CAR on a quarterly basis as per approved work plan;






13. Be accountable to the completeness, validity and accuracy of the data on the documents submitted;
14. Disburse the fund in accordance with government accounting and auditing rules and regulations;
15. Submit monthly audited liquidation report to DA-RFU, CAR duly certified by the Chief Accountant and approved by the Bureau Director;
16. Issue official receipt upon receipt of the fund transferred; and
17. Return to DA-RFU, CAR any unutilized balance.


The agreement shall take effect upon receipt of fund transfer. This MOA may be modified in writing by mutual agreement of both parties.




