OVERVIEW OF GHANA STATISTICAL SERVICE

The Statistics Act 37 was promulgated in 1961 to provide for the collection, analysis and publication of statistical data relating to economic and social matters and for the establishment of a statistical service. The Act established the Central Bureau of Statistics under the direct control and superintendence of the Government Statistician. In 1985, PNDC Law 135 established the Statistical Service thus repealing the Statistics Act 37.

Under the leadership of the Government Statistician the Statistical Service among other things should perform the following functions;

1. Advice the Government on matters related to statistics
2. Collects, compiles, analyse abstract and publish statistical information related to the commercial, industrial, agricultural, social, economical, financial, and other activities of residents in Ghana
3. Conducts sample surveys and any census in Ghana
4. Organise a co-ordinated scheme of socio-economic statistics relating to Ghana
5. Publish such socio-economic data on Ghana as may be permitted.

It must be noted that the Service also has data bases on Consumer Prices, National Accounts, Internal and External Trade and Establishments Register which are updated monthly.

Various publications have been produced from these surveys not only by the Statistical Service but other institutions and individual researchers. The living standards survey is intended to highlight and monitor the living conditions of the Ghanaian society. It provides a basis on which to:

- Monitor the effects that the policies of the government and various donor contributions have on the well-being of the Ghanaian population. It gives the various users a system of social indicators against which to monitor development.
- Serve as a national baseline to which survey coverage e.g. vulnerable groups, special items or geographical areas could be compared.
- Give rapid, reliable information on key social indicators
- Establish a very flexible and cost-effective data collection system.

The fourth round of the GLSS has the following objectives:

- To provide information on patterns of household consumption and expenditure disaggregated at greater levels.
- In combination with the data from the earlier rounds to serve as a data base for national and regional planning.
- To provide in-depth information on the structure and composition of the wages and conditions of work of the labour force in the country.

- To provide benchmark data for compilation of current statistics on average earnings, hours of work and time rates of wages and salaries that will indicate wage/salary differentials between industries, occupation, geographic location and gender.

Additionally, the survey will enable policy-makers to

- identify vulnerable groups for government assistance;
- analyse the impact of decisions that have already been implemented and of the economic situation on living conditions of households;
- monitor and evaluate the employment policies and programmes, income generating and maintenance schemes, vocational training and similar programmes. The joint measure of employment, income and expenditure provides the basis for analysing the adequacy of employment of different categories of workers and income-generating capacity of employment-related economic development.

1. FOREWORD

This report presents the main results of the Fourth Round of the Ghana Living Standards Survey (GLSS4) with labour force module. The fieldwork covered a period of 12 month (April 1998 to March 1999) nearly seven years after the third round of the survey. The survey instruments and methodology were based on those of the third round with very minimal modifications.

Since the introduction of the Structural Adjustment Programmes (SAP) poverty alleviation, monitoring and evaluation of welfare information systems has been the focal point of Government policy and programmes. Additionally, Government is concerned about labour information systems particularly on employment, underemployment and unemployment on continuous basis consequent on the SAP as a component of the general Economic Recovery Programme (ERP) launched in 1983.

Current data collection on employment do not allow the compilation of comprehensive monthly or annual labour statistics such as trends in unemployment, the number of people actively looking for work or self-employed. Information on conditions of work; wage/salary payment schedules, overtime, bonuses, incentives and contributions to pension and social security schemes are not co-ordinated. Additionally, there is the need for data on the labour force engaged in the various sectors of the economy so that appropriate target groups can be identified for assistance. Hence, the need to include the labour force module in the fourth round of the GLSS.

The GLSS4 was a nation wide survey which collected detailed information on a variety of topics including; demographic characteristics of the population, education, health employment and time use, migration, housing conditions, household agriculture and non-farm businesses. It is expected that together with the results of the earlier rounds the GLSS4 will provide expanded information to policy-makers, business persons and academic analysts for evaluating living standards and labour force information systems in the Country.

For purposes of comparability the income and expenditure module used in the third round survey was not modified. This is particularly useful as it will enable the evaluation of poverty trends over the survey period. Researchers who are interested in carrying out further analysis with the GLSS data sets are encourage to apply through the Government Statistician for further details.

4. PURPOSE OF THE SURVEY

The fourth round of the GLSS has the following objectives:

- To provide information on patterns of household consumption and expenditure disaggregated at greater levels.
- In combination with the data from the earlier rounds to serve as a database for national and regional planning.
- To provide in-depth information on the structure and composition of the wages and conditions of work of the labour force in the country.
- To provide benchmark data for compilation of current statistics on average earnings, hours of work and time rates of wages and salaries that will indicate wage/salary differentials between industries, occupations, geographic locations and gender.

Additionally, the survey will enable policy-makers to

- Identify vulnerable groups for government assistance;

- Analyse the impact of decisions that have already been implemented and of the economic situation on living conditions of households;
- Monitor and evaluate the employment policies and programmes, income generating and maintenance schemes, vocational training and similar programmes. The joint measure of employment, income and expenditure provides the basis for analysing the adequacy of employment of different categories of workers and income-generating capacity of employment-related economic development.

5. *SAMPLE DESIGN AND SAMPLING METHOD*

A nationally representative sample of households was selected in order to achieve the survey objectives.

5.1 Sample Frame

For the purpose of this survey the list of the 1984 population censal Enumeration Areas (EAs) with population and household information was used as the sample frame. The primary sampling units were the 1984 EAs and the secondary units being the households in the EAs. This frame, though quite old and may be considered rather inadequate, is the best available in the system. Indeed, this frame was used for the earlier rounds of the GLSS.

5.2 Stratification

In order to increase precision and reliability of the estimates the technique of stratification was employed in the sample design using geographical factors, ecological zones and location of residence as the main controls. Specifically, the EAs were first stratified according to the three ecological zones namely; Coastal, Forest and Savannah, and then within each zone further stratification was done based on the size of the locality into rural or urban.

5.3 Sample Selection

5.3.1 EAs

A two-stage sample was selected for the survey. At the first stage, 300 EAs were selected using systematic sampling with probability proportional to size method (PPS) where the size measure is the 1984 number of households in the EA. This was achieved by ordering the list of EAs with their sizes according to the strata. The size column was then cumulated, and with a random start and a fixed interval the sample EAs were selected.

It was observed that some of the selected EAs had grown in size over time and therefore needed segmentation. In this connection, such EAs were divided into approximately equal parts, each segment constituting about 200 households. Only one segment was then randomly selected for listing of the households.

5.3.2 Households

At the second stage, a fixed number of 20 households was systematically selected from each selected EA to give a total of 6,000 households. Additionally 5 households were selected as reserve to replace missing households.

The above sample selection procedure deviated slightly from that used for the earlier rounds of the GLSS, as such the sample is not self-weighting. This is because,

1. given the long period between 1984 and the GLSS4 fieldwork the number of households in the various EAs are likely to have grown at different rates.
2. the listing exercise was not properly done as some of the selected EAs were not listed completely. Moreover, it was noted that the segmentation done for larger EAs during the listing was a bit arbitrary.

5.4 Computation of Weights

In order to get the true contribution of each selected EA in the sample, weights were computed based on the true sizes of the EAs since 1984 using the household listing from the 2000 population and housing census conducted by the GSS. Even though the survey fieldwork was completed about a year ago before the census, in practice, the results will not differ significantly.

Let M_i = Number of 1984 population census household in the i^{th} selected EA

M_i^* = Number of 2000 Population households in the i^{th} selected EA

α = Number of EAs selected at the first stage
ie. α = 300

β = Number of households selected at the second stage
ie. β = 20

$$\text{Then } P_{1i} = \frac{\alpha M_i}{\sum M_i} \quad \text{and} \quad P_{2i} = \frac{\hat{a}}{M_i^*}$$

where P_{1i} and P_{2i} are the first and second stage probabilities of selection respectively

The overall probability of selection of households in a given EA is,

$$F_i = P_{1i} P_{2i} = \frac{\alpha \hat{a}}{\sum M_i} * \frac{M_i}{M_i^*}$$

The weighting coefficient for the i^{th} EA W_i , is given by the reciprocal of the overall probability of selecting that EA.

$$\text{Hence, } W_i = \frac{1}{F_i} = \frac{\sum M_i}{\alpha \hat{a}} * \frac{M_i^*}{M_i}$$

Given that $\alpha = 300$ and $\beta = 20$ and $\sum M_i = 2,444,836$ (from 1984 census sample frame) then,

$$W_i = 407.5 * \frac{M_i^*}{M_i}$$

The weights are contained in the data file labelled Pov_gh.

5.5 Survey Coverage

Out of the selected 6000 households 5999 were successfully interviewed. One household was further dropped during the data cleaning exercise because it had very few records for many of the sections in the questionnaire. This gave 5998 household representing 99.7% coverage. Overall, 25,694 *eligible household members* (unweighted) were covered in the survey.

6. GENERAL CONCEPTS AND DEFINITIONS

Household: In this survey, a household was defined as a group of people who have usually slept in the same dwelling and taken their meals together for at least 9 of the 12 months preceding the interview. The following are examples of a household.

- (i) A household consisting of a man and his wife/wives and children, father/mother, nephew and other relatives or non-relatives;
- (ii) A household consisting of a single person;
- (iii) A household consisting of a couple or several couples with or without their children.

Dwelling: This is a structure or group of structures (room(s) or buildings/compounds), separate or contiguous, occupied by members of the household. It can be:

- * a single family house/hut
- * a flat/apartment (self-contained)
- * rooms (compound house)
- * several huts/buildings (same compound)
- * several huts/buildings (different compound).

Household Head: Usually the head of the household is the person who provides most of the needs of the household and also takes most of the major decisions affecting the welfare of the household. He/she is most familiar with all the activities and occupations of the household members. In any case he/she will be the person named when you ask the question "Who is the head of this household?"

Usual member of household: All persons who slept in the same dwelling and took their meals together for at least 9 of the 12 months preceding the interview were considered as members of the household whether present or absent at the time of interview. In other words, all persons who had been away from the household for more than three months were not considered household members except,

- 1. the person identified as the head of household even if he has not been with the household for 9 months or more;
- 2. children under 9 months old;
- 3. students, seasonal workers or any such persons who had not been living in or as part of another household.

Enumeration Area (EA)/Cluster: It is a demarcated geographic area consisting of a locality or group of localities with boundary description which usually can be managed by one enumerator. On average EAs have about 200 households.

Urban EA: An EA was considered to be urban if it had a population greater than 1,500 people during the 1984 population census. Thus semi-urban EAs (with population between 1,501 and 5,000) were considered as urban assuming that they might have grown to urban status since the 1984 census.

Rural EA: An EA was considered to be rural if it had a population 1,500 or less people during the 1984 population census.

7. DESCRIPTION OF THE QUESTIONNAIRES

The main questionnaire used in the survey was the household questionnaire. In addition to this, there were community and Price questionnaires.

7.1 Household Questionnaire

The household questionnaire was used to collect information on various topics some of which pertain to eligible individual household members. The questionnaire is in two parts, A and B.

7.1.1 PART A

7.1.1.1 Section 1: Household Roster

The purpose of this section is to identify usual members of households, and to collect demographic data such as age, sex, marital status etc. regardless of his or her other socio-economic standing.

7.1.1.2 Section 2: Education

The objective of this section is to measure the level of education or formal schooling of all household members aged five (5) years or more. It is also intended to measure how much was spent on education of household members during the past 12 months, time spent on primary schooling, type of school (public or private) attended and the highest educational qualification achieved, including short training course. Information on adult literacy levels and apprenticeship of persons was also collected in this section.

7.1.1.3 Section 3: Health

This section gathers information on health status of all household members that will be used to measure the cost of medical care and the use made of the different kinds of health services and facilities available. Information on preventive services during the past 12 months, fertility and child mortality is collected.

7.1.1.4 Section 4: Employment

This section is designed to gather information on employment, time use and the different sources of income for household members aged 7 years and over. This section was the main module of the survey and has been expanded into detail.

7.1.1.5 Section 5: Migration

The purpose of this section is to gather data on the geographic mobility of household members. The section is brief as such focuses on the most recent migration and elicits information on previous place of residence, type of work and reasons for moving.

7.1.1.6 Section 6: Identification of Respondents for Next visits

This section is mainly used to identify eligible members of household and make appointments with them for sections 8, 9, and 10 of the questionnaire.

7.1.1.7 Section 7: Housing

The quality of house occupied by the household is paramount to the welfare of the members. In this regard, the section seeks information on the type of dwelling, occupancy status, number of rooms and room space, expenditures, utilities and amenities as well as the physical characteristics of the dwelling.

7.1.2 PART B

7.1.2.1 Section 8: Agriculture

The purpose of this section is to collect data on the household's agricultural activities. It covers agricultural assets such as land, livestock and equipment. Furthermore, it provides data on agricultural production, technology, processing, marketing, income and consumption patterns.

7.1.2.2 Section 9: Household Expenditure

This section collects data on expenditures of households on food and Non-food items over a period of 35 days.

7.1.2.3 Section 10: Non-Farm Enterprise

This section is designed to obtain information on income for the household specifically from Non-Farm Enterprises. It also identifies which household members are responsible for each non-farm enterprise in terms of decision making and the allocation of income it generates. Non-Farm Enterprises that are currently operating and those that were operational some time in the past 12 months but currently not operating are considered.

7.1.2.4 Section 11: Remittances

Information on cash and/or in-kind remittances is collected in this section. Transfers to the household are considered as income whereas transfers from the household constitute expenditures. In the analysis however, net remittance is used.

7.1.2.5 Section 12: Credit, Assets and Savings

This is the last section of the questionnaire and it is designed to collect information on Loans, Assets and Savings. The household members who contracted the loans and those operating savings accounts are identified for interviewing.

7.2 Community Questionnaire

The main aim of the community questionnaire was to identify the economic infrastructure, education and health facilities existing in the villages, as well as any related problems that affects their welfare. The questionnaire was administered in the rural EAs only.

7.3 Price Questionnaire

As part of the survey a price questionnaire was designed to collect prices of most essential commodities in the local markets.

8. DATA COLLECTION

8.1 Field Survey Operations

8.1.1 Survey Period

The survey was spread over a 12-months period (from 1st April 1998 to 25th March 1999) in order to ensure continuous recording of household consumption and expenditures and changes occurring thereof. The year was divided into 10 cycles of 36 days each. Interviews were conducted on the first 35 days of each cycle while the 36th day was used for travelling by the team to the next set of EAs.

Eleven field teams were involved in the data collection. The purpose of the eleventh team was to afford each of the 10 regular teams the opportunity to take 1 month off as annual leave.

8.1.2 Fieldwork

The constitution of each of the field teams is shown below:

- 1 Supervisor
- 4 Interviewers
- 1 Driver
- 1 Data Entry Operator

The Supervisor was the team leader and was responsible for overseeing, monitoring and, where necessary, correcting the work of the interviewers and the data entry operator. In addition, he was responsible for managing the team's equipment, vehicle and funds.

The senior interviewer conducted his/her normal interviews and only assumed the role of the supervisor when the latter was not available, for example when he/she was indisposed.

The interviewers conducted daily interviews with the household. To avoid any interruption in the survey schedule, three interviewers were always at work while the fourth takes some rest. The data

entry operator entered the data collected from the field onto a microcomputer, while the driver was to drive the team from and to the Teams data collection zone.

Each selected household was visited 7 times at 5 days interval. Specific sections of the questionnaire are administered at each visit. A diary of daily consumption and expenditure was used to support the expenditure data collection in order to reduce memory lapse. During the first visit a literate person was identified in each household and briefly trained by the enumerator to record all subsequent expenditures made by the household and to submit the diary to the interviewer on his/her next visit for entry into the appropriate sections in the main questionnaire. Where a household has no literate member the supervisor made daily visits to the household to record all expenditures in the diary meant for the household. Throughout the period of the survey enumerators worked in separate EAs.

During each cycle the supervisor, assisted by the enumerator on leave administered the community and price questionnaires.

9. DATA PROCESSING

9.1 Training

The project had 3 experienced computer programmers responsible for the data processing. Data processing started with a 2-weeks training of 15 data entry operators out of which the best 10 were chosen and 2 identified as standby. The training took place one week after the commencement of the fieldwork

9.2 Data entry

Each data entry operator was assigned to one field team and stationed in the regional office of the GSS. The main data entry software used to capture the data was IMPS (Integrated Microcomputer Processing System). The data capture run concurrently as the data collection and lasted for 12 months.

9.3 Tabulation/Analysis

The IMPS data was read into SAS (Statistical Analysis System), after which the analysis and generation of the statistical tables were done using SAS.

10. DATA QUALITY

It is a policy of the GSS to produce good quality data for use by policy-makers and researchers. In this connection, various measures were taken during and after the GLSS4 data collection to ensure that the data quality was not compromised.

10.1 Supervisors

As the leader, each of the 10 field teams of the survey had an experienced supervisor who had taken part in similar surveys conducted by the Service. He/She was assisted in the field by an equally qualified field-editor.

10.2 Supervisory visits

Also field supervisors from the GLSS4 Secretariat paid surprise visits to the enumerators in their various EAs to find out how fieldwork was going on and to help solve pressing issues that cropped up in the course of their work.

10.3 Consistency checks

Checks were also built in the data entry programs to detect any inconsistencies in the course of entering the data. After a batch consisting of 20 households in an EA has been entered, the consistency program in CONCOR is run and errors corrected before the data is copied and sent to head office for processing.

10.4 Data Cleaning Workshops

Two separate workshops were organised for 3 programmers and 2 statisticians of the Secretariat with Mr John Y. Ngwafon as consultant from the World Bank for data cleaning. First, the team went through a two-week training workshop in December 1998 on data cleaning. This was after the first six months of data collection, and this afforded us the opportunity to identify the problem areas of the questionnaire so as to ensure that the next six months data errors were minimised. The data cleaning team travelled to all the regional offices where data entry took place and checked through all problem questionnaires for correction. It also gave the team the opportunity to caution any supervisor/enumerator/data entry operator who was repeatedly making the same mistakes.

A second workshop was organised at the end of the fieldwork and data capture in May 1999 to clean the rest of the data.

11. OTHER AVAILABLE DATA

Below is a list of other surveys that have been carried out by the Ghana Statistical Service. Users, passing through the right channels could have access to the data. Apart from the third and fourth rounds of the GLSS, which are on this CD-ROM, the data for the first and second rounds are also available on diskettes and may be obtained through the same procedure outlined above. A fee is charged for the release of the entire data set.

3-9: Clerical And Related Workers Not Elsewhere Classified

Workers in this minor group perform various clerical and related duties not elsewhere classified. Included are those who record the receipt, storage, weighing and issuing of finished goods or materials; despatch, receive, store issue and weight processes; calculate quantities needed and draw up correspondence; provide information and services to visitors in agencies; code and compile statistical data; operate office machines for reproducing copies of documents; operate addressing machinery; carry out other recording correspondence and filing tasks.

4-9: Sales Workers Not Elsewhere Classified.

Workers in this unit group perform various selling tasks not elsewhere classified. Their functions include: lending money to customers on pledge or bonds; selling refreshments and confectionery at places of entertainment; performing various other selling tasks.

6-4: Fishermen, Hunters and Related Workers Not Elsewhere Classified.

Workers in this unit group perform a variety of fishing hunting and related tasks not classified elsewhere. Their functions include: breeding and raising fish; cultivating oysters, trapping and hunting wild animals; performing related tasks.

7-7: Food And Beverage Processors.

Workers in this category prepare food products and beverages of all kinds for human and animal consumption. The underlisted unit groups fall into this category. Grain Millers and related workers; sugar processors and refiners; butchers and meat preparers; food preservers; dairy product processors; bakers, pastry cooks and confectionery makers; Tea, coffee and cocoa preparers; Brewers, wine and beverage makers.

Food and Beverage Processors Not Elsewhere Classified.

This unit group perform tasks not classified elsewhere in the preparation and processing of food products for human and animal consumption: example, extracting oil from oil-bearing seeds, nuts and fruits.

9-4: Production And Related Workers Not Elsewhere Classified.

Workers in this minor group include craftsmen and specialised workers performing functions requiring application of particular techniques, use of particular tools or machines, abilities and experience in working particular materials in order to make such articles as musical instruments; baskets and brushes; artificial stone and other non-metallic mineral products; dolls, rubber stamps etc. The group also includes those who prepare and stuff skins of animals and birds to give them life-like forms.

Include preparing, preserving and canning of meat fish and crustacea; manufacture of dairy products, manufacture of vegetable and animal oil fats; grain and mill products; manufacture of bakery products; manufacture of chocolate and sugar confectionery; and lastly local food preparation like kenkey, tuo, koko, kelewele, doughnuts, etc.

620 Retail Trade

Retail/Sale of petrol and related petroleum products; sale of kerosine; sale of cloth; petty trading; selling of newspapers; foodstuff selling; fruit, fish and meat selling; coalpot selling etc.

621 Restaurants, Cafes and Other Eating and Drinking Places

1. A Poles is equivalent to 210 feet by 210 feet or 70 by 70 yards, which is equivalent to one Acre.
