SERIES INFORMATION

The country conducted the first Census of Agriculture (CA) in 2007.

ABSTRACT

The Census of Agriculture in the Republic of Macedonia was conducted in the period from 1 to 15 June 2007. The data in the Census forms have been recorded according to the situation on 31 May 2007, and for certain questions the data refer to the period of one year prior to the Census, namely from 1 June 2006 to 31 May 2007.

The following units were covered by the Census:

- Individual agricultural holdings
- Households that own forest
- Households that own fish pond
- Business entities and the local units which in accordance to the National Classification of Activities, by main activity are distributed in the sector of Agriculture, hunting and forestry and
- Business entities and the local units which in accordance to the National Classification of Activities, by main activity are not distributed in the sector of Agriculture, hunting and forestry, but which perform activities in this sector (agricultural schools, borstals, agricultural scientific institutes, religious communities and other).

The CA 2007 covered the following types of holdings: (i) holdings in the household sector ("individual agricultural holdings" and households that own forest and/or fish ponds); and (ii) holdings in the non-household sector (business entities).

SAMPLING PROCEDURE

The CA 2007 was organized according to the concept of complete coverage ("door to door"), which means that during the CA, all households on the territory of the Republic of North Macedonia were visited and recorded. The CA 2007 was conducted using complete enumeration.

DATA COLLECTION NOTES

Census data collection from holdings in the household sector was carried out by trained enumerators, using the PAPI method. Business entities were required to fill in the census questionnaires themselves and send them by post to the State Statistical Office (self-interviewing, mail-out/mail-back method).

Questionnaires

QUESTIONNAIRES

Two forms were used for census data collection:

- Questionnaire for individual agricultural holdings (Form ZEM.R1)- for individual agricultural holdings, as well as for households that own forest or fish ponds; and
- Questionnaire for business entities (Form ZEM.P.2) - for business entities and local units covered by the census.

The census covered all 16 core items recommended in the WCA 2010.

Data Processing

DATA EDITING

Data capture was done using manual data entry. The software used for data processing, analysis and tabulation was SAS. The PES was performed to check the quality of census data. Fifty EAs were selected for the PES and approximately 2 percent of the total number of individual agricultural holdings were interviewed.

Data Appraisal

DATA APPRAISAL

The final census results were published in three volumes (one for business entities and two for individual holdings) in December 2007. The publications include data on the national and regional level (according to the Nomenclature of Territorial Units for Statistics, NUTS 1 and 3 level). The publications and other census results are available on the institution's website.
