ABSTRACT

The Food and Agriculture Organization of the United Nations (FAO) has developed a monitoring system in 26 food crisis countries to better understand the impacts of various shocks on agricultural livelihoods, food security and local value chains. The Monitoring System consists of primary data collected from households on a periodic basis (more or less every four months, depending on seasonality). FAO conducted a household survey in Haiti through the Data in Emergencies Monitoring (DIEM) system. The survey started from November 24 to December 24, 2022. The survey employed random digital dialing to select households. A total of 2 053 households were reached, a representative at the department level. The survey targeted all ten departments of Haiti: Artibonite, Centre, Grand'Anse, Nippes, Nord, Nord-Est, Nord-Ouest, Sud, Sud-Est, and Ouest. - CROP PRODUCTION : crops planted, area planted, area harvested, crop production difficulties
- CROP MARKETING : crop sale difficulties, crop sale price
- LIVESTOCK PRODUCTION : types of livestock present on holding, number of livestock, livestock production difficulties
- LIVESTOCK MARKETING : livestock sale, livestock sale difficulties, livestock sale price
- FISHERIES PRODUCTION : fish activity, comparison of fish production
- FISHERIES MARKETING : fish sale, fish sale difficulties, fish sale price
- FOOD SECURITY AND CONSUMPTION : food consumption, food utilization, coping strategies
- NEEDS ASSISTANCE : open questions on the needs for assistance

Sampling

SAMPLING PROCEDURE

The 2 053 households were selected through random digital dialing. Fourteen strata were created from the ten departments to increase rural respondents' representation and enhance the representation of certain livelihood zones, particularly Artibonite HT04 (rice, plantains) and Ouest HT05 (banana plains of Arcahaie).

WEIGHTING

Data were weighted at administrative level 1 using education weights to correct for potential bias introduced towards urban and wealthier households due to the use of phone interviews. Base weights using population counts were created for the 14 strata to distinguish different population sizes and wealth for livelihood zones within the same department.
